Proposed removal of term limit relating to the office of the President and Vice President

Article 42 of the Memorandum and Articles of Association of The Hong Kong Former Immigration Service Staff Association Limited stipulates that "(t)he retiring members of the Executive Committee shall be eligible for re-election except that the President and the Vice President shall not serve in the same office for more than two consecutive terms". At the 186th meeting of the Executive Committee, a question was raised under "Any Other Business", namely, whether or not the stipulated term limit should be removed. The Committee discussed the matter at considerable length and eventually came to a conclusion that there should be a comprehensive consultation to hear out the views of the members. A consultation paper setting out the arguments for and against the removal was issued to all 392 members in January 2021. Of the 247 replies received before the deadline, 157 or 64% were in favour of removal. In the circumstances, the Committee decided at its 188th meeting to put the matter of removing the term limit to an extraordinary general meeting for a Subject to an affirmative resolution, Article 42 will be amended to read as follows: "The retiring members of the Executive Committee shall be eligible for reelection", with "except that the President and the Vice President shall not serve in the same office for more than two consecutive terms" deleted.

Proposed Amendment to Article 43

Article 43 of the Memorandum and Articles of Association of The Hong Kong Former Immigration Service Staff Association Limited reads as follows: "A member of the Executive Committee who ceases to be a member of the committee shall, within 14 days of his ceasing to be a member, hand over to the secretary or, if the secretary is not readily available, the President or Vice President or in their absence of the committee any books or records of account, papers, documents and other records in respect of the control, management and administration of the Association together with any movable property belonging to the Association that are under his control or in his custody or possession". It came to the recent notice of the Executive Committee that the following part of the Article was not clear and coherent: "..... the President or Vice President or in their absence of the committee any books or". A search of records, including the final draft of the said Memorandum and Articles of Association as cleared by the founding members, revealed that two words, namely, "any member" between "in their absence" and "of the committee" were missing.

At its189th meeting, the Committee was unanimous in its view that the two missing words should be put back to where they belonged. Since the insertion, simple as it might appear, was tantamount to a material change to the Article, the Committee was of the further view that it should be put to an extraordinary general meeting for a resolution. Subject to an affirmative resolution, Article 43 will be amended to read as follows: "A member of the Executive Committee who ceases to be a member of the

committee shall, within 14 days of his ceasing to be a member, hand over to the secretary or, if the secretary is not readily available, the President or Vice President or in their absence any member of the committee any books or records of account, papers, documents and other records in respect of the control, management and administration of the Association together with any movable property belonging to the Association that are under his control or in his custody or possession".

N.B.: According to legal advice available to the Executive Committee, both items above are within the meaning of a special resolution. Pursuant to section 564 of the Companies Ordinance (Cap 622), a special resolution is passed if it is passed by a majority of at least 75% of the eligible members who vote in person or by proxy on the resolution at a general meeting.
